Fees for S Applications – Modification of Consents

- ◆ **S(1):** No Fee
- ◆ **S(1A):** \$645 or 50% of the original Development Application (DA) Fee, whichever is the lesser
(In some instances, Council's Assessment Officer may authorise a reduced fee of \$110 if, in their opinion, the extent of change is inconsequential)
- ◆ **S(2):** Fees for modifications under S (2) will be charged as follows:
 - (i) in the case of a modification application with respect to a DA that does not involve the erection of a building, the carrying out of a work/demolition of a work or building, 50% of the original DA fee; and
 - (ii) in the case of a modification application with respect to a DA that involves the erection of a dwelling-house with an estimated cost of construction of \$100,000 or less, \$190; and
 - (iii) in the case of a modification application with respect to any other DA, the fee shall be levied in accordance with the following table:

Estimated Cost*	Maximum Fee Payable
Up to \$5,000	\$55
\$5,001- \$250,000	\$85, plus an additional \$1.50 for each \$1,000 (or part of \$1,000) of the estimated cost.
\$250,001-\$500,000	\$500, plus an additional \$0.85 for each \$1,000 (or part of \$1,000) by which the estimated cost exceeds \$250,000.
\$500,001- \$1,000,000	\$712, plus an additional \$0.50 for each \$1,000 (or part of \$1000) by which the estimated cost exceeds \$500,000.
\$1,000,001- \$10,000,000	\$987, plus an additional \$0.40 for each \$1,000 (or part of \$1000) by which the estimated cost exceeds \$1,000,000.
More than \$10,000,000	\$4,737, plus an additional \$0.27 for each \$1,000 (or part of \$1000) by which the estimated cost exceeds \$10,000,000.

* Estimated cost of the development for which development consent was originally granted.
